Other Business	T2/T1044: The Council discussed AUGSAs administrative improvements over the past several years shifting critical operational functions from students in short-term roles to full-time staff. The Executive Director noted AUGSA has made leaps and bounds in progress over the past number of years, and that while AUGSA has met all the requirements for audits and financial management. AUGSA has never
	and financial management, AUGSA has never exercised an annual filing, which is not uncommon for a non-profit or a student run organization to overlook. The Executive Director recommended that given the significant improvements to management and shift in governance in the past several years, AUGSA should do so moving forward starting in 2023. AUGSA is in the process of acquiring requests for quotes for an auditor. During the auditor selection process, the Association will be including additional annual work as part of the request for quotes, meaning the quotes will be higher than what we have traditionally paid over the past number of years.
