# 8.0 Council Member Responsibility Overview:

M. Sullivan provided a presentation on the role of Council, and the responsibilities of Council Members with a focus on two primary areas of focus: student representation and governance. The presentation included an overview on the history of AUGSA, including the transition to a governance model on May 1st, 2023 called Policy Governance, also known as the "Carver model". The overarching focus is that Council will govern with an emphasis on outward vision committed to obtaining membership input, encouraging a diversity of viewpoints, and being proactive and future focused.

Accompanying the overview included the following objectives for the first 3-months of the Council's term to get them 'up and running':

## Student Representation

- Selection and assignment of portfolios and attending representation meetings;
- Review of current advocacy priorities of the membership;
- Addressing the concerns regarding the Alberta Graduate Provincial Advocacy Council (abGPAC) and determining next steps;
- Attendance at the Canadian Alliance of Student Associations (CASA) conference in Ottawa (May 13 – 17); and
- Attendance at the Athabasca University Convocation (June 18 19).

### Governance

- Complete the online 9-module governance training provided by The Governance Coach, which includes the following coaching session checkpoints with AUGSA's Coach, Andrew Bergen: May 7, May 21, June 4;
- Conduct monthly Council meetings including submission of progress reports;
- Revisions to bylaws required prior to the Annual General Meeting (reviews completed by June 18 Council Meeting); and
- Schedule the Annual General Meeting for July 16th. The audit and any bylaw changes are approved at this meeting. 21 days notice is required of the meeting, and 14 days notice to send out meeting materials.
