Inputed changes made at prior meetings:

Article 6.1.2 - Members of the Executive shall be elected annually at the annual general meeting. The term of office shall be one (1) year running from **September** to **August**.

Article 6.1.3 - Nomination for the Executive shall open **May** and shall close seven (7) business days prior to the annual general meeting

Article 6.3.1 - Nominations for councilors-at-large shall open **May** and shall close seven (7) business days prior to the annual general meeting

New bylaw change:

Article 6.1.6 - In the case of a vacancy on the Executive, a by-election shall be held in accordance with 6.4 or by appointment.

Bylaw changes adopted by Executive Committee.

Action: Further review of Bylaws is required and this will come forward at the upcoming meetings to ensure consistency of terminology, definitions and timelines. Clarification of the AGM in the by-laws.
